TO APPLY FOLLOW THESE STEPS:

- Read the Terms and Conditions on this form to ensure you qualify for the rebate.
- Your primary heating source must be electric.
- Insulation and/or windows must be purchased and installed by December 31, 2019.
- Installer and homeowner must sign, date and complete this form as well as provide the following items:
 - Insulation: Purchase Receipt/Invoice Copy of insulation certificate
 - Windows: Purchase Receipt/Invoice Window Specification Sheet (which includes U-Factor and sq. ft.)

TERMS AND CONDITIONS

Please refer to the following terms and conditions prior to signing acceptance:

- You must be a customer of Seattle City Light (City Light) and the installation address is in the City Light service area. Existing single-family residences (1-4 units) qualify. Primary space heating must be electric.
- This application must be postmarked within 90 days of purchase. Work must be paid for and installed by December 31, 2019.
- It is City Light's intent to mail the appropriate rebate check within sixty days of receipt of a completed application. Lack of documentation or information from the Program Participant to City Light will delay rebate processing.
- This rebate form and program documentation is subject to Washington's Public Records Act, RCW Chapter 42.56.

Specific terms and conditions for insulation projects:

- A rebate of 50% of cost (including materials, labor and tax) is available for insulation projects. Rebates are capped per residence at \$500 for attic work, \$500 for wall work and \$200 for floor work.
- Work must be installed in accordance with manufacturer's specifications by a licensed contractor.
- Contractor must certify existing and new levels of insulation and invoice must be itemized with the following: sq. ft., R-Value, and cost. A copy of the insulation certificate must be submitted with this application.
- Pre-existing and new insulation levels must be within the existing R-Values and Post R-Values listed on page two.

Specific terms and conditions for window/patio door projects:

- A \$50 per window/patio door rebate is available for the replacement of existing single pane with any frame type or double pane with metal frames, to windows with a U-Factor rating of 0.30 or lower and patio doors with a U-Factor of 0.35 or lower. Windows and patio doors are defined by windows and frame, not just glass replacement.
- Replacement of existing double pane windows with vinyl frames do not qualify.
- Windows/patio doors must be installed in a conditioned space. Conditioned space is defined as space that is heated.
- Windows must be contractor installed. A window specification sheet must document U-Factor and sq.ft. of each window and/or patio door and be submitted with this application.

By submitting this rebate form, Program Participants recognize that prior to payment City Light may contact the applicant, related vendor or installer to evaluate installation information, inspect the installed product listed on this form, and request the Program Participant to submit supporting documentation. City Light will review the project to determine eligibility and qualification for a rebate in accordance with these terms and conditions. This program is completely voluntary, and Program Participant assumes any risks of injury, property damage, and expenses that may arise during the implementation of these energy conservation measures.

City Light does not make any representations, promises, or warranties for any efficiencies of potential energy savings, installed products, materials, equipment fitness, labor required, or merchantability for any purpose. Program Participant represents and warrants that all installed requirements are in compliance with all applicable federal, state and local laws, codes, ordinances, including all building energy and accessibility codes and in compliance with these terms and conditions.
